



My Way 2 – COVID19 information pack

Plan of action: an organised programme of measures to be taken in order to achieve a goal. Our goal: The welfare of all aboard My Way 2

1. General Information

1.1 While social distancing measures are still being advised, we have to limit the number of anglers aboard My Way 2 to a maximum of 6.

1.2 Meet at boat as per normal, adhering to social distance measures.

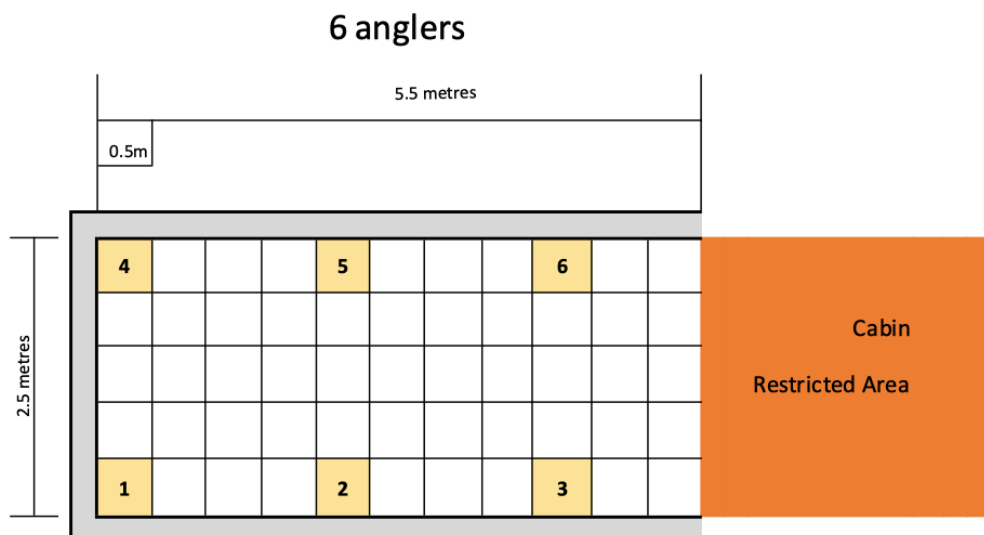
1.3 We have purchased a large supply of hand foam wash sanitiser, dispensers and antibacterial handwash.

1.3.1 In addition we have also purchased a touchless infrared hand sanitiser dispenser, that is mounted on the outside rear of My Ways cabin. Anglers will be requested to sanitise their hands as they step aboard and encouraged to do so once more when leaving.

1.3.2 Antibacterial handwash will be readily available for anglers through the day.

1.4 Limiting the boat to 6 anglers, we will maintain the 2m Social Distance Guideline. Boarding of the boat will be in the order displayed. Disembarking a reversal of embarkation.

1.4.1 Each 2m Social distance area will be clearly marked on deck, gunwales and rails! Anglers will be expected to respect these areas & not move around the boat.

- 1.5 Access to the cabin for storage of personal items or seating whilst traveling to and from our intended fishing mark will be denied. As anglers we often bring far more than required. I urge everyone to consider lightening their load and create more space around the boat.
- 1.6 We will continue to supply tea & coffee, however, replace our mugs with disposable cups that should be placed in the bin after use. We will for the time being no longer be supplying a hot snack and refuse access to our cooking facilities. We recommend all anglers bring a packed lunch and soft drinks.
- 1.7 We have increased the number of rubbish bins aboard My Way 2 and request they are used as per normal from your allocated position. We will then dispose of the rubbish at the end of the day.
- 1.8 Access to the toilet will still be available in only extreme circumstances.
Toilet facilities are cleaned & disinfected every evening as part of our normal routine, this practise will continue with added attention to ensuring all handrails and other exposed areas of possible contamination are correctly disinfected.
- 1.8.1 If an angler uses the toilet facilities, they are requested to wipe down all surfaces after use with the toilet wipers and dispose of the wipe in the bin provided.
- 1.9 Buckets will be provided into each position, with lanyard so anglers can obtain fresh water. Additionally, individual brush heads and bait boards supplied. Buckets will be disinfected, all lanyards left overnight in a 1:50 dilution of bleach/water overnight.
- 1.10 Facemasks & Visors
- 1.10.1 Facemasks are currently not compulsory; they are an option for anglers.
- 1.10.2 We have acquired a supply of washable face masks, enough for 3 days of maximum 6 anglers and crew.
- 1.10.3 These are readily available for anglers to use free of charge.
- 1.10.4 At the end of the day, anglers deposit their masks in our washbag, and the masks will then be boil washed then dried in preparation for use again in two days.
- 1.10.5 Face visors are currently not compulsory; they are an option for anglers.
- 1.10.6 We have acquired a supply of 20 Medical face visors, enough for 2 days of maximum 6 anglers and crew.
- 1.10.7 These are readily available for anglers to use free of charge.
- 1.10.8 At the end of the day, anglers leave their face visors in their allocated position and the masks will then be disinfected during our deep clean and left for a further two days before use again.
- 1.10.9 In these times of national crises, we encourage all anglers to come equipped with anything they feel comfortable and safe with – gloves, masks, visors etc.

2. Individual, small group and full boat bookings.

- 2.1 With the reduction in numbers aboard My Way 2, for cost purposes and in the interest of fairness all bookings will be treated as individual.
- 2.2 This will be implemented initially for June, July & August 2020 and be under constant review as per Government advice.

3. New Price structure

Unfortunately our business is not supported by any Welsh or UK Government grant scheme released as a result of this pandemic.

- 3.1 Our price structure needs to change to ensure operational costs are covered over coming months in addition to maintaining our survival for when we return to our normal compliment of anglers.
- 3.2 A general 8hr charter previously priced at £40 with 10 anglers, would ideally need to increase to £66 to maintain business commitments and income. We appreciate that such an increase is not possible across the board in such unprecedented times and financial concerns for us all.

We are implementing the following price increases to ensure business and running costs are maintained and My Way 2 remains operational

- 3.2.1 8hrs General Fishing £50
- 3.2.2 9hrs Holyhead Deep £55
- 3.2.3 10hrs Caernarfon Bay £65
- 3.2.4 10hrs Wreck Fishing £100

- 3.3 We are in touch daily with various authorities and political parties in the hope to achieve some level of support. These prices are subject to change. Any changes will be notified to all anglers immediately.
- 3.4 This will be implemented initially for June, July and August 2020 and be under constant review as per Government advice.

4. Payment

- 4.1 We are happy to receive cash payment, you are encouraged to have the correct amount.
- 4.2 BACS, Card or PayPal payments are accepted, these electronic transfers are to be made on the evening before your trip once sailing is confirmed.
- 4.3 A secure COVID19 payment page will be released on our website when we resume operations to make online card payments straight forward the evening before.

5. Hire rods & reels

- 5.1 Our rods and reels are available for any anglers that wish to use them. Looking at information on Covid-19 lifespan – up to 3days is the generally accepted maximum

We have a large selection of rods and reels for varying styles of fishing. Different class rods for example 12lb, 20lb, 30lb Touch tips etc. Along with a sufficient number of reels to suit.

It is our intention to wash down and sanitize each rod and reel after use. They will be separated from the others and left for a period of 3 days before being used once again.

Naturally this may mean that normally where a 12lb class is used, we may only have a 30lb class or lighter available. However within the current situation it is prudent that we take any precaution we deem necessary.

6. General & Deep Cleaning

- 6.1 We will expect everyone aboard to help with the cleaning of fishing related mess in their allocated area. This will then give us a working platform for a deep clean once everyone has left.
- 6.2 Once anglers have disembarked, we will clean the whole of the deck & gunwale areas with disinfectant and sanitising products in preparation for the next day.

7. Responsibility

As a business we continue to maintain all required licenses to operate within the law and MCA Code Of Practice.

Our Duty of Care at sea remains unchanged and we strive as ever to offer an enjoyable and safe time afloat

During the COVID19 pandemic we are all ultimately responsible for our actions and ensuring the safety of ourselves and all around us. Please be thoughtful and considerate to everyone you meet aboard My Way 2

8. Considerations

8.1 Holyhead Marina & Holyhead Sailing Club are situated in both a public and residential area. All anglers are requested to continue to park at the top of the hill and make their way to the boat. Please adhere to social distancing measures on the short journey down to My Way 2 with respect for the residents and staff.

8.2 Tackle & Bait

8.2.1 Tackle - we encourage anglers to shop local and support local tackle shops. Naturally also appreciate this is not always possible and may require additional travel. End tackle can be provided by us, along with rods and reels as required.

8.2.2 Bait - we encourage anglers to shop local and support local tackle shops. Naturally also appreciate this is not always possible and may require additional travel. Bait can be supplied upon request; under current social distancing guidelines bait will be supplied as individual packs per angler and not a communal pot as often was the case previously.

8.3 Travel

8.3.1 Where ever possible, it is advisable to travel direct to us with no stops.

8.3.2 Public amenities, breakfast stops, comfort breaks etc. Please remember that many places will remain closed or have strict social distancing measures in place. Anglers are requested to consider this when preparing their journey to us
